Royal Club Rules And Management policies

In Order to make your stay as pleasant as possible, the Management requests your co-operation in observing the following as an agreement between the guest and the "Royal Club Bonnington":

1. Timeshare owners

All Timeshare owners are entitled to use one week per year or more subject to the initial signed agreement.

Time share owners lose their weeks automatically if they did not send any notifications to the management of the club about their shares.

2. Tariff

The usage of unit is exclusive of any government taxes applicable Meals and other services are available at extra cost. To know your unit tariff, please contact customer service at mezzanine floor in Bonnington the phone number is 00971 (4) 3560502, guest registration forms must be signed on arrivals.

3. Check-in

Check in time 04:00PM Dubai time and check out 11:00 AM Dubai time. Please present your ID card, Passport or Temporary Residence Card upon Check-in. By Law visitors must present personal documents for hotel records. These documents will be returned upon departure, the refundable security deposit is 274\$.

4. Capacity of the unit:

One bedroom is for four persons only, two bedrooms are for six persons only, and 3bedrooms are for eight persons only.

4. Departure

Check out time is 11:00 AM please inform the reception if you wish to retain your unit beyond this time. Extension will be given depending on the availability. If the unit is available, normal tariff will be charged. On failure of the guest to vacate the room on expiry or period the management shall have the right to remove the guest and his/her belongings from the room occupied by the Guest.

5. Guest's Belongings

Guests are particularly requested to lock the door of their rooms when going out going to bed. For the convenience of the Guest, electronic safety lockers are provided in the room to store any valuables.

The Management will not in any way whatsoever be responsible for any loss / or damage to the Guest's belongings or any other property from either the hotel room or the locker or any other part of the hotel for any cause whatsoever including theft of pilferage.

6. Pets

Pets are not allowed.

7. Hazardous Goods

Bringing goods and / or storing of raw or exposed cinema films or any other article of a combustible or hazardous nature and / or prohibited goods and / or goods of objectionable nature is prohibited.

The Guest shall be solely liable and responsible to the management, its other guests, invitees visitors, agents and servants for all loss financial or otherwise and damage that may be caused by such articles or as a result of the guests' own negligence and non-observance of any / instructions.

Gambling, contraband, prostitution, weapons, explosives, flammable objects, poisons, drugs, animals and pungent food are strictly prohibited on the Royal club premises.

8. Damage to Property

The guest will be held responsible for any loss or damage to the Royal Club property caused by themselves, their guests or any person for whom they are responsible.

9. Management's Rights

It is agreed that the guest will conduct him/ her in a respectable manner and will not cause any nuisance or annoyance within the hotel premise.

The Management has the right to request any guest to vacate his/her room or other areas of the hotel forthwith, Without previous notice and without assigning any reason whatsoever, and the guest shall be bound to vacate when requested to do so. In case of the default the Management has the right to remove the Guest luggage and belongings from the room occupied by him / her.

10. Relation between Management and Guest

Nothing herein above shall continue or be deemed to constitute, or create any tenancy or subtenancy, or any other right to interact in the Royal Club Bonnington premises or any part of portion thereof, in favor of any Guest or resident or visitor, and the Management shall always be deemed to be in full and absolute possession of the whole of the club premises.

11. Government rules and regulations and application of laws

Guest are requested to observe, abide by confirm to and be bound by all applicable acts and laws and Government rules and regulations in force from time to time.

12. Photographs and Video's

Using photographs and video's taken in Royal Club units for commercial or a public purpose is illegal. Those who do so will be subject to prosecution.

13. Quran and prayer mat for Muslims will be provided upon request.
